The University of South Carolina - Columbia has entered into a dual degree program agreement with La Universidad Austral in Buenos Aires, Argentina. The agreement will allow students to earn a Doctor of Philosophy (Ph.D.) degree in Business Administration from the University's Darla Moore School of Business, and a Ph.D. in Business Administration from La Universidad Austral. Students must meet the degree requirements of each institution; doctoral research will be collaboratively supervised with dissertation committees consisting of faculty from both entities.

A copy of the signed Agreement of Academic Cooperation was provided which includes the requirements for students participating in the dual degree program and outlines the responsibilities of all parties. In addition, it contains a disclaimer which states SACSCOC accreditation does not extend to other entities. After successful completion of the program, graduates will receive two separate degrees.
